

Training Workshop on

Methodological Issues in Family and Migration Research

Course Outline

The training course will span over a total of 7 working days. Participants will be divided into two groups, Group 1 and Group 2 according to their backgrounds, research interests and research proposals to best fit into the quantitative and qualitative areas respectively. Group 1 will be headed by Dr Khoo Siew Ean, and Group 2 by Mr Johannes Pfliegerl. Both groups will be taught together by the trainer-in-charge in each day, but the different groups have specific presentations to be made on the days specified compulsory for them.

The exercise will focus on appropriate definitions of migrant status, identification of the relevant census questions that can be used to identify migrant status, development of indicators of migrant welfare and adjustment, identification of covariates, and analysis of data on household and family structure. Participants will present their plan of analysis for group discussion.</p>

The exercise will focus on constructing tabulations that examine change in migrant status over time.</p>
